ARRL Simulated Emergency Test ("SET") – October 2-3

Proposal:

A coordinated ARES/RACES Simulated Emergency Test Exercise for Santa Barbara Section stations.

Let's work together on this exercise to test and improve our network, train our operators and provide an opportunity to consume mass quantities of donuts and coffee, etc.

For a scenario, we need to use something big that would involve several counties, perhaps a large scale terrorist event.

Scenario:

- Coordinated attacks on our Southern CA Nuclear Plants, Diablo Canyon and San Onofre, with associated utility power outages.
- Dept. of Homeland Security suspends cellular service Nationwide due to terrorists using cell phones to detonate explosive devices at infrastructure locations like communication and transportation sites and petrochemical distribution facilities. (Well, okay Mike, but a more realistic scenario is that the cellular network becomes heavily overloaded with traffic, and cell sites that have lost commercial power and don't have generators are QRT. Most cell sites do not have emergency generators and are reliant on a T-1 telephone circuit to connect to the switching office. –ed)

Each participating station would be provided with scenario details, simulate trouble in their local area of operations including agency support and support requests and enter this message traffic into our network by contacting Net Control Stations at Emergency Operations Centers. Some stations may operate mobile to simulate field deployment. EOC's may be required to contact other counties to relay message traffic and send simulated support requests. If we have an idea of who will participate, we can really tweak the scenario and enhance realism by addressing exercise traffic to specific Emer. Ops Centers, etc. that require simulated replies.

We'll need to coordinate nets and frequencies:

- HF and VHF/UHF voice mode primary and secondary for each County/Area
- HF voice and/or digital mode primary and secondary exclusively for EOC stations
- HF and VHF/UHF digital modes including Winlink and packet for Section

Many of these frequencies may already be specified in SOP's for your area. All formal message traffic should use National Traffic System format.

Alternatively, please review the "experimental and un-official" ARES/RACES Message Format shown below. We used this shortened message format in San Luis Obispo during a recent FEMA/OES/Diablo Canyon Exercise and many operators who are not familiar with the NTS format found this abbreviated version easier to work with and in some cases more effective.

Ideas from our membership can be put together into an overall Exercise Operations Plan that'll be sent to all participants in advance. If we're all working from the same plan, we can guide our training and test specific functions. The most important part of any exercise is the After Action Report. Each participating station should send an AAR to his ARES EC. A consolidated Section AAR should be distributed to all member stations to pass on lessons learned.

Sounds like fun to me. If this sounds like fun to you, let's do it! Kick around the idea with your members and maybe we should discuss further at next Section meeting. There's interest from ARES folks in Monterey and Orange County, as well as probable Army, Navy-Marine Corps and Air Force MARS participation to test interoperability. October is out on the horizon and approaching fast, so thought I'd get the ball rolling. Any comments welcome.
