Treasurer's Report – Jane KF6QHP

The Club closed the year with \$447 in the Treasury, \$327 as the December 31 reconciled bank balance and \$120 in petty cash. There are a few accruals outstanding, such as fish fry receipts. The Christmas party drew \$240 in 2005 memberships; the raffle fetched \$70 after costs; and the silent auction raised \$75 free and clear.

Overall 2004 cash flows were in deficit mode, owing to the items highlighted in yellow. We need to improve collections and make sure we get the donations we have historically relied upon. We also need to try and increase our membership, perhaps with a personal outreach campaign to people we know who have not been active in the Club.
